A. APPROVAL OF AN APPLICATION SUBMITTED BY MICHELLE MCKINLEY-TARANGO TO BEGIN RECEIVING RETIREMENT BENEFITS THROUGH THE PUBLIC SAFETY PERSONNEL RETIREMENT SYSTEM (PSPRS) AND TO TERMINATE ENROLLMENT IN THE DEFERRED RETIREMENT OPTION PLAN (DROP) PROGRAM.
